TOWN OF LEGAL BY LAW #07-2016 UTILITY PRE-AUTHORIZED PAYMENT PLAN BYLAW

A BYLAW OF THE TOWN OF LEGAL IN THE PROVINCE OF ALBERTA TO PROVIDE A PRE-AUTHORIZED PAYMENT PLAN FOR UTILITY ACCOUNTS.

WHEREAS the Municipal Government Act, RSA 2000, c. M-26 provides that a Council may pass bylaws respecting public utilities; and

WHEREAS this Bylaw is to ensure each Consumer is aware of the requirements of the Town of Legal Utility Pre-Authorized Payment Plan (Pre-Authorized Debit (PAD));

NOW THEREFORE, the Municipal Council of the Town of Legal in the Province of Alberta, duly assembled, hereby enacts as follows:

DEFINITIONS

- 1. "Consumer" means any person to whom the Town of Legal supplies utility services, and in whose name an account has been opened with the Town of Legal for the purpose of providing utility services as defined in the Water Bylaw #08-2016, Wastewater Bylaw #09-2016 and Waste Collection Bylaw #10-2016.
- 2. "PAD" means Pre-Authorized Debit.

PRE-AUTHORIZED PAYMENT PROCESS

- 1. An Agreement, stipulating the terms, conditions, and penalties of the Utility Pre-Authorized Payment Plan for pre-authorized payment withdrawal is attached to this Bylaw as Schedule "A" and forms part of this Bylaw.
- 2. Consumers can only sign up to the Utility Pre-Authorized Payment Plan if the balance owing on the Consumers utility account is zero (\$0.00) at the time Schedule "A" is submitted.
- 3. Payments will be collected from Consumers bank accounts as follows:
 - i. Consumers on a Monthly Billing Cycle: on the fifteenth (15th) day of every month or the next business day.
 - ii. Consumers on a Bimonthly Billing Cycle: on the fifteenth (15th) day or the next business day of the months of February, April, June, August, October, December.
- 4. If a Consumers payment is returned, a service charge fee, as per Fee Schedule Policy 2.10, will be automatically applied to the Consumers account.
- 5. In the event of a returned payment, the payment, penalties and the service charge will be withdrawn from the Consumers bank accounts as follows:
 - i. Consumers on a Monthly Billing Cycle: by the twenty-fifth (25th) of every month or the next business day.
 - ii. Consumers on a Bimonthly Billing Cycle: on the fifteenth (15th) day or the next business day of the months of January, March, May, July, September, November.

If the second attempt for withdrawal is returned this shall result in the Consumers termination from the Utility Pre-Authorized Payment Plan.

- 6. Consumers may choose to withdraw from the Utility Pre-Authorized Payment Plan, upon completion of the Cancellation of Pre-Authorized Payment Plan, attached to this Bylaw as Schedule "B".
- 7. Consumers must return Schedule "B" no later than fifteen (15) business days prior to the next withdrawal/due date.
- 8. The Town of Legal reserves the right to remove any Consumer from the Utility Pre-Authorized Payment Plan at any time.



EFFECTIVE DATE

This Bylaw shall come into force upon third and final reading.

- 3. I/We hereby understand that any returned payments are subject to a \$25.00 service charge and may result in my/our termination from this plan. I/We understand that in the event of a returned payment, the payment and service charge will be added to the next month's withdrawal.
- In the event of the sale of the above noted property, I/we will notify the Town of Legal, in writing at least fifteen (15) days prior to the next due date, to arrange for withdrawal from the plan.
- 5. In the event of change in bank account, I/we will notify the Town of Legal, in writing at least fifteen (15) days prior to the next due date, to provide the new bank account information.
- Nothing in this Pre-Authorized Payment Plan form shall be interpreted to relieve the owner/applicant from the obligation to pay any utility charges, including penalties, owing to the Town of Legal in the manner or on the date(s) for payment established by the bylaws of the Town of Legal.
- 7. I/We understand there will be monthly charges in the amount of the payment and we will be notified of the withdrawal amount on the Town of Legal Utility Statement as indicated by the balance owing.
- 8. I/We have certain recourse rights if any debit does not comply with this agreement. For example, I/we have the right to receive reimbursement for any Pre-Authorized Debit that is not authorized or is not consistent with this Pre-Authorized Debit agreement.
