

BY LAW #64-93

A BY LAW OF THE VILLAGE OF LEGAL IN THE PROVINCE OF ALBERTA, to execute an agreement with Northwestern Utilities Limited, hereinafter referred to as the "Company", to renew a contract with, and to confer a special franchise on the Company to supply natural gas to customers within the municipality.


WHEREAS the Company has requested a special franchise be granted to provide natural gas services to customers within the municipality;

AND WHEREAS it is deemed that such an agreement would be of benefit to customers within the Village of Legal;


THEREFORE under the authority of the Municipal Government Act, R.S.A. 1980, Chapter M-26, Section 281 be it enacted that the Mayor and Administrator be authorized to sign the agreement which is attached to and forming part of this By Law and marked as Schedule "A" between the Village of Legal and the Company to renew a contract with and to confer a special franchise on the Company to supply natural gas services with the Village of Legal;

This by Law shall come into force upon the agreement being approved by the Public Utilities Board for the Province of Alberta, and upon given Third reading and finally passed.





SCHEDULE "A"

RENEWAL OF A NATURAL GAS SUPPLY
AND SPECIAL FRANCHISE CONTRACT

The Council of the Municipality hereby applies to the Public Utilities Board for approval to renew a natural gas supply and special franchise contract between the Municipality and Northwestern Utilities Limited for a period not in excess of ten (10) years.

Enclosed herewith is a copy of By Law #64-93 read the first time on the 18th day of January, 1993 A.D.

The Council hereby declares:

- a) That the privilege or franchise granted under the natural gas supply and special franchise renewal contract is necessary and proper for the public convenience and properly conserves the public interests.
- b) That the scheme of Northwestern Utilities Limited for the supply of natural gas under the provisions of the natural gas supply and special franchise renewal contract is reasonable and sufficient having regard to the general circumstances.
- c) That with respect to the supply of natural gas to the Municipality the natural gas supplier has provided the construction, equipment, maintenance, service or operation as the public convenience and interests reasonably require.
- d) That having regard to the availability of any other source of supply of natural gas in the area in which the Municipality is situated and to any other circumstances, the granting of the franchise or privilege in the natural gas supply and special franchise renewal contract is to the general benefit of the area directly or indirectly affected thereby.
- e) That the natural gas supplier has fully discussed all proposed changes to the natural gas supply and special franchise contract with the Council and the Council understands the reasons for these amendments and is in agreement with them.
