BACKGROUND / PROPOSAL:

Sturgeon Valley Fertilizers (SVF) has procured the naming rights of the Legal Arena & Curling Rink (now called "SVF Sports Centre"). In accordance with the Naming Rights Agreement between SVF and the Town of Legal:

- 10. The costs for the design, construction, purchase, installation, and maintenance of the portion of the Signage as it relates to the logo of "SVF" or wording of "Sturgeon Valley Fertilizers" and any feature such as LED lighting, electrical requirement shall be payable by the NRS. The Town will pay for utility consumption of the Signage.
- 11. The costs for the construction, purchase, installation, and maintenance of the portion of the Signage as it relates to the wording "Arena & Curling Rink" shall be payable by the Town.


Administration has been working with 3 different vendors to secure quotes for the facility signage. Quotes from Behrends Group is attached (Quote #54188 reflects the Town of Legal's portion for the signage).

Administration is recommending Council to proceed with the SVF Sports Centre naming rights signage as described in Quote #54188, and that the Town of Legal submit the cost to Delnor Construction Ltd. as part of the Legal Arena and Curling Rink Retrofit project costs.

DISCUSSION / OPTIONS / BENEFITS / DISADVANTAGES:

Quote #50343 (SVF portion) = \$21,608.16 plus GST, includes any lettering pertaining to SVF or Sturgeon Valley Fertilizers. The upper letters "SVF" are backlit (the words "sturgeon valley fertilizers" is not backlit). The lower level will be lit by an external source (under canopy lighting).

Quote #54188 (Town portion) = \$22,658.28 plus GST, includes the lettering "SPORTS CENTER" on the upper level and is all backlit. The lower level will not have any lighting.





COSTS / SOURCE OF FUNDING (if applicable):

Town portion Quote # 54188 = \$22,658.28 + GST = \$23,791.19

RECOMMENDED ACTION (by originator):

It is recommended that Council proceed with the SVF Sports Centre naming rights signage as described in Quote #54188, and that the Town of Legal submit the cost to Delnor Construction Ltd. as part of the Legal Arena and Curling Rink Retrofit project costs.
