Staff Sergeant Darcy McGunigal, Morinville RCMP

Mayor Tremblay welcomed Staff Sergeant Darcy McGunigal to the Council meeting. S/Sgt McGunigal provided to Council the quarterly update covering the period from April 1 to June 30, 2025 which provides a snapshot of human resources, financial data, and crime statistics for the Morinville RCMP Detachment.

The Morinville RCMP Detachment is comprised of 40 personnel and provides 24-hour policing services to several municipalities and communities including the Town of Legal, Alexander First Nation, Sturgeon County, Town of Bon Accord, Town of Gibbons and the Town of Morinville.

The 2025/26 Policing Priorities include (1) Property Crime Reduction, (2) Community Engagement, and (3) Police Visibility. Total RCMP calls for service with the Town of Legal for 2025 Quarter 1 (56) are down compared to 2024 Quarter 1 (63). S/Sgt McGunigal reviewed notable investigations and mentioned the Monthly Roundup that is provided to the Town of Legal for public consumption.



The Morinville RCMP Detachment has also been busy with Community Engagement, attending Morinville Show n' Shine, hosting Coffee with Cop sessions, participating in the Sturgeon Regional Positive Ticketing program, and with working with the schools on the School Resource Officer Program. The Detachment also assisted with Legal Citizens On Patrol's recent recruitment in May.

Mayor Tremblay thanked Staff Sergeant for the presentation and quarterly update.
